- a. The inability to perform physical examinations or certain diagnostic tests
- b. Potential for technical difficulties that may disrupt or delay the consultation
- c. Possible need for in-person follow-up visits if the telemedicine consultation is insufficient
- 6.4 Technical Issues: You acknowledge that technical difficulties may occur and interrupt service. If a telemedicine session is interrupted and cannot be resumed, you should call our office to schedule an inperson appointment if necessary.
- 6.5 Privacy Risks: While we use secure platforms for telemedicine services, you acknowledge that electronic communication comes with inherent privacy risks. We will take all reasonable precautions to protect your information, but we cannot guarantee the security of data transmitted over the internet.

7. MEDICAL RECORDS

- 7.1 Record Retention: We maintain medical records in accordance with law and regulations, which generally require retention for at least 7 years from the last date of service.
- 7.2 Access to Records: You have the right to access your medical records. To request access, please contact our office in writing. We may charge a reasonable fee for copying and mailing records.
- 7.3 Release of Records: We will only release your medical records with your written authorization or as required by law.

8. INTELLECTUAL PROPERTY

- 8.1 Ownership: The Website and its entire contents, features, and functionality are owned by the Physician and are protected by United States and international copyright, trademark, patent, trade secret, and other intellectual property or proprietary rights laws.
